(If it appears from the statement of applicant or otherwise that such applicant has been convicted of a felony involving moral turpitude, or adjudged guilty of violating the prohibition laws, either State or Federal, within the last two years prior to the filing of the application, or within two years from the completion of sentence, such license shall not be granted; and if it shall afterwards appear that any false statement is knowingly made in any part of said application and license received thereon, the license of the applicant shall be revoked and the applicant subjected to the penalty provided by law for misdemeanors.)

Premises, for and on which license to sell is hereby applied for, are either inside a municipality or unincorporated town or village having police protection or, if outside, not within 300 feet of any public or private school buildings or church building. (See Section 512 and Section 513.)

It is understood that the granting of license by any municipality or county under the Beverage Control Act shall not be a valid license until such licensee shall have complied with the requirements of the State Commissioner of Revenue and as stipulated in Section 519 of the Beverage Control Act; providing for bond or satisfactory contract or agreement to cover the tax liability of licensee.

In consideration of the foregoing provisions and statements by me, which I declare under oath to be true, I respectfully request that license be issued as herein applied for.
